1 (WHEREUPON, THE PROCEEDINGS WERE HELD AS FOLLOWS:)

2 BOARD PRESIDENT DR. GRUBBS: We're going
3 to call to order the November 7th meeting of
4 the Mississippi State Board of Dental
5 Examiners.

6 If you would, let's bow our heads and have
7 a prayer, please.

8 (Invocation)

9 BOARD PRESIDENT DR. GRUBBS: Okay. We
10 would like to welcome our visitors. If you
11 would, please stand and let us know who you
12 are and who you represent, please.

13 MR. CAMP MURPHY: Camp Murphy with
14 Capitol Resources.

15 MS. EKLUND: Neva Eklund; I'm a policy
16 advocate for the Mississippi Academy of
17 Pediatric Dentistry.

18 MR. JONES: Felda Jones; Morton,
19 Mississippi; Mobile Health Solutions and
20 Forest Dental Practice.

21 DR. WILLIAMS: I'm Mark Williams
22 representing myself.

23 MS. SIMMONS: Lindsey Simmons; Simmons
24 Consulting.

25 MR. LAMB: Patrick Lamb, General

1 Dentist; Mobile Health Solutions and
2 Ellisville Dental Center.

3 MR. MIKE MURPHY: Mike Murphy; Mobile
4 Health Solutions. I live here in Flowood,
5 Mississippi.

6 MS. BAILEY: Katherine Bailey; Smiles to
7 Go.

8 MS. DARCY CASEY: Darcy Casey.

9 MR. CASEY: Lee Casey, General Dentist.

10 MS. ASHLEY CASEY: Ashley Casey with
11 Smiles to Go.

12 BOARD PRESIDENT DR. GRUBBS: All right,
13 Denny. Do we have enough folks to get this
14 thing kicked off?

15 EXECUTIVE DIRECTOR MR. HYDRICK: We do,
16 yes, sir. We have a quorum.

17 BOARD PRESIDENT DR. GRUBBS: At this
18 time, we have --

19 BOARD VICE-PRESIDENT DR. CURTIS:
20 Mr. President?

21 BOARD PRESIDENT DR. GRUBBS: Yes, sir?

22 BOARD VICE-PRESIDENT DR. CURTIS: May I
23 please ask for a moment of personal
24 privilege?

25 BOARD PRESIDENT DR. GRUBBS: Absolutely.

1 BOARD VICE-PRESIDENT DR. CURTIS: Thank
2 you.

3 I would just like to take this opportunity
4 to thank all of the Board members for the
5 donation that was made to the Baptist
6 Children's Village in memory of my mother. I
7 know that Lewis had a lot to do with this. His
8 wife serves on that Board, and I know Denny was
9 involved as well. But I accept this gift from
10 each of you. It means a lot to my family, and
11 I know my mother would approve.

12 Thank you.

13 BOARD PRESIDENT DR. GRUBBS: Yes, sir,
14 appreciate it.

15 Okay. At this time, we have a new Board
16 member, and we need to swear him in.

17 Dr. Donald, if you would, stand and please
18 repeat after me.

19 (WHEREUPON, WILLIAM MARK DONALD, DMD,
20 SOLEMNLY SWORN IN AS A BOARD MEMBER OF THE MSBDE)

21 BOARD PRESIDENT DR. GRUBBS: Okay. We
22 have a recognition today. In our presence,
23 we have a special guest; that's Dr. Mark
24 Williams.

25 Mark, would you come up here, please? You

1 thought you were going to get away, didn't you?

2 I will tell y'all, he may be the longest
3 serving Board member. Do you think? I might
4 be right.

5 DR. WILLIAMS: May be.

6 BOARD PRESIDENT DR. GRUBBS: He was
7 supposed to leave in 2023, and he just left a
8 week ago. So that meant he was doing a
9 wonderful job.

10 So, Mark, we do appreciate you.

11 DR. WILLIAMS: Well, thank you.

12 BOARD PRESIDENT DR. GRUBBS: I thank you
13 so much for your friendship.

14 And, look, for dedication and services of
15 the citizens of Mississippi as the President of
16 the Mississippi State Board of Dental Examiners
17 (tenders award).

18 DR. WILLIAMS: Thank you.

19 BOARD PRESIDENT DR. GRUBBS: We
20 appreciate you.

21 Okay. My mother-in-law used to call these
22 "accolades."

23 The next thing we have is Dr. Lampkin.
24 Would you please stand?

25 Now, she just got married. I know y'all

1 can tell by that beam around her face. But,
2 also, she is recognized as a 2025 recipient of
3 the Ole Miss Outstanding Young Alumni Award,
4 which is a big deal.

5 We appreciate you. That's a wonderful
6 thing. Thank you so much.

7 BOARD MEMBER DR. LAMPKIN: Thank you.

8 BOARD PRESIDENT DR. GRUBBS: Okay. Now,
9 I think we turn it over to Denny.

10 EXECUTIVE DIRECTOR MR. HYDRICK: Yes. I
11 just wanted to quickly introduce -- is Keith
12 here? In here? I wanted to make sure
13 everyone meets our newest staff member and
14 investigator, Keith McElveen. Keith is a
15 seasoned law enforcement -- trained law
16 enforcement officer, and we are glad to have
17 him. And he will poke his head in in just a
18 minute, and we'll acknowledge that when he
19 comes in.

20 (INVESTIGATOR KEITH MCELVEEN ENTERS HEARING ROOM)

21 EXECUTIVE DIRECTOR MR. HYDRICK: Keith,
22 we were just introducing you. I wanted to
23 just have everyone be able to put a face and
24 name together.

25 This is Keith McElveen, Investigator with

1 the State Dental Board.

2 Keith, glad you're here.

3 BOARD PRESIDENT DR. GRUBBS: Yes.

4 AGENDA ITEMS

5 BOARD PRESIDENT DR. GRUBBS: All right.

6 At this time, if -- I'm sure everybody has
7 gone through our previous minutes, so we need
8 to approve those.

9 Does anybody got any questions?

10 BOARD VICE-PRESIDENT DR. CURTIS: I move
11 that we approve.

12 BOARD PRESIDENT DR. GRUBBS: Second?

13 BOARD MEMBER MS. BIRMINGHAM: Second.

14 BOARD PRESIDENT DR. GRUBBS: All in
15 favor?

16 BOARD PANEL: Aye.

17 BOARD PRESIDENT DR. GRUBBS: All right.
18 That's great.

19 Now, I'm sure this will take a few
20 minutes, but we need to decide how we're going
21 to work next year with these dates. Denny said
22 we can't change them, so we ought to be able to
23 go over them pretty quick and be done with
24 them. So look at those.

25 EXECUTIVE DIRECTOR MR. HYDRICK: I will

1 note that the January 23rd meeting date,
2 there is not a district meeting that day.
3 And so, that's why I chose that Friday, so
4 that each Board member has the opportunity to
5 go to their district meeting if they want to,
6 as this would not impact that.

7 BOARD PRESIDENT DR. GRUBBS: Is
8 everybody okay with those?

9 (No response)

10 BOARD PRESIDENT DR. GRUBBS: All right.
11 We need a motion, please.

12 BOARD MEMBER DR. CARLTON: So moved.

13 BOARD PRESIDENT DR. GRUBBS: Second?

14 BOARD MEMBER DR. JOE: Second.

15 BOARD PRESIDENT DR. GRUBBS: All in
16 favor?

17 BOARD PANEL: Aye.

18 BOARD PRESIDENT DR. GRUBBS: All right.

19 Here we go. "Committee Reports."

20 Dr. Curtis, "Rules and Regs."

21 BOARD VICE-PRESIDENT DR. CURTIS: Sir,
22 we had a meeting last night, and there are
23 two action items that I would like to bring
24 to the Board:

25 One was in regard to Regulation 13. The

1 recommendation was made that the line item that
2 states that a practicing dentist can have up to
3 three registered, qualified dental hygienists
4 approved to practice under general supervision.
5 We amended that to allow for a dentist to have
6 an unlimited number of hygienists -- qualified
7 hygienists registered to practice under general
8 supervision, but only three can practice at a
9 time. And that amendment was approved by the
10 Committee, and I would move that recommendation
11 to this Board this morning.

12 BOARD MEMBER DR. BISHOP: So moved.

13 BOARD MEMBER DR. LAMPKIN: Second.

14 BOARD PRESIDENT DR. GRUBBS: Any
15 discussion on that?

16 (No response)

17 BOARD PRESIDENT DR. GRUBBS: All in
18 favor?

19 BOARD PANEL: Aye.

20 BOARD VICE-PRESIDENT DR. CURTIS: The
21 second action item had to do with Regulation
22 53. After taking a close look at the work
23 that we had done last year, we decided that
24 the third section of that regulation that
25 deals with informed consent had some language

1 that was vague, at best, and that needed to
2 be cleaned up. And so, the Committee voted
3 to pull that entire section out and send it
4 back to Rules and Regs for next year, and
5 we'll try to clean that up and resubmit it.

6 So that memo was approved by the
7 Committee, and I would move recommendation to
8 the full Board this morning.

9 BOARD PRESIDENT DR. GRUBBS: Do we have
10 a second?

11 BOARD MEMBER DR. CARLTON: Second.

12 BOARD PRESIDENT DR. GRUBBS: Any
13 discussion?

14 EXECUTIVE DIRECTOR MR. HYDRICK: May I
15 make just a clarifying note?

16 BOARD VICE-PRESIDENT DR. CURTIS: Yes,
17 sir.

18 BOARD PRESIDENT DR. GRUBBS: Yes.

19 EXECUTIVE DIRECTOR MR. HYDRICK: So the
20 actual recommendation is to keep the other
21 amendments in Regulation 53 and go ahead and
22 send that forward through the OLRC process.
23 And so, it's removing the entire Section
24 No. 3, but everything else is moving forward.

25 BOARD VICE-PRESIDENT DR. CURTIS: Right;

1 correct.

2 BOARD PRESIDENT DR. GRUBBS: All in
3 favor?

4 BOARD PANEL: Aye.

5 BOARD VICE-PRESIDENT DR. CURTIS: That's
6 all I have, Mr. President.

7 EXECUTIVE DIRECTOR MR. HYDRICK:

8 Dr. Curtis, we have one more item.

9 BOARD VICE-PRESIDENT DR. CURTIS: Okay.

10 EXECUTIVE DIRECTOR MR. HYDRICK: It's
11 the new Regulation 11 on the criminal
12 background.

13 BOARD VICE-PRESIDENT DR. CURTIS: Oh,
14 yeah. I forgot about that. I apologize.

15 We have a new regulation that you can find
16 before you that has to do with the methodology
17 for doing criminal background checks on new
18 licensees, and we'll have that available to
19 everybody in full detail, as you wish to review
20 it.

21 But that was passed, and I would move that
22 recommendation to the full Board this morning
23 as well.

24 BOARD PRESIDENT DR. GRUBBS: Do we have
25 a second?

1 BOARD MEMBER DR. JOE: Second.

2 BOARD PRESIDENT DR. GRUBBS: Discussion?

3 (No response)

4 BOARD PRESIDENT DR. GRUBBS: All in
5 favor?

6 BOARD PANEL: Aye.

7 BOARD VICE-PRESIDENT DR. CURTIS: Now I
8 think I'm done.

9 BOARD ATTORNEY MR. MUTZIGER: And I
10 would add, just to supplement Dr. Curtis'
11 report, that Regulation 41 we did file
12 amendment to, and that was to remove the
13 section for continuing education requirements
14 that provides for the Board to be an approver
15 or an approving entity of continuing
16 education and, instead, to defer that to
17 other entities that are already existing and
18 performing that function.

19 That public comment period has now
20 expired, and we have not received any public
21 comments regarding that. As such, unless there
22 is -- unless it's the will of the Board that
23 the action not be taken, I will proceed along
24 with filing that with the OLRC, as that's the
25 next step in the process.

1 BOARD PRESIDENT DR. GRUBBS: Is that it?

2 BOARD ATTORNEY MR. MUTZIGER: Yes, sir.

3 BOARD PRESIDENT DR. GRUBBS: Ms.

4 Birmingham?

5 BOARD MEMBER MS. BIRMINGHAM: I have
6 nothing to report.

7 BOARD PRESIDENT DR. GRUBBS: I have
8 nothing on the "Practice Act and
9 Legislative." I'm sure things will heat up
10 pretty soon. We do have a meeting, and
11 that's just a --

12 Denny, am I correct, is that December 4th
13 just in case we need it; is that correct?

14 EXECUTIVE DIRECTOR MR. HYDRICK: If it
15 is needed, that's right.

16 BOARD PRESIDENT DR. GRUBBS: Dr.
17 Lampkin?

18 BOARD MEMBER DR. LAMPKIN: I have
19 nothing to report.

20 BOARD PRESIDENT DR. GRUBBS: Dr. Bishop?

21 BOARD MEMBER DR. BISHOP: With "Budget
22 and Finance," we have the year-end of fiscal
23 year 2025 report, as well as the first
24 quarter for fiscal year 2026.

25 And I'm going to ask Denny if he would

1 bring it up and go through it right quick?

2 EXECUTIVE DIRECTOR MR. HYDRICK: At the
3 last Board meeting in September, we did look
4 at the end of the fiscal year financials;
5 however, there's an additional quarter that's
6 allowed to pay any outstanding expenses that
7 were actually incurred. So the final numbers
8 were submitted in this Board packet.

9 And, you know, unless someone has specific
10 questions about that, I think we came in -- I
11 think it was a couple hundred thousand under
12 budget as far as our expenses. Yeah, we had
13 \$197,810.66 that was not spent that had been
14 budgeted. Of course, our expenses were higher
15 in the fiscal year '25 because of the move and
16 the transition to the new software system. So,
17 you know, \$250,000 or so are expenses that
18 won't be incurred moving forward.

19 So any questions about the end of the
20 fiscal year '25?

21 (No response)

22 EXECUTIVE DIRECTOR MR. HYDRICK: And
23 does anybody have any questions about the
24 first quarter of fiscal year '26?

25 (No response)

1 BOARD PRESIDENT DR. GRUBBS: We
2 appreciate Dr. Bishop for putting that thing
3 together.

4 BOARD MEMBER DR. BISHOP: Yeah.

5 BOARD PRESIDENT DR. GRUBBS: Anything
6 else?

7 EXECUTIVE DIRECTOR MR. HYDRICK: I did
8 have one thought that I would like to note
9 because I think this is important to note.

10 The Board, at the end of the fiscal year
11 '25 and the first year of fiscal year '26, has
12 spent almost \$77,000 of budgeted funds towards
13 facility inspections across the State. So
14 these are dollars that will not be recovered.
15 There's no permit fee that was attached to
16 those as far as the inspections.

17 And so, I think that's worth noting, that
18 the Board has invested upwards of \$77,000 in
19 the protection of the public and supporting our
20 permit holders and being in compliance with our
21 Regulation 30.

22 So we're thankful that the Board has been
23 willing to use those funds for that purpose.

24 BOARD PRESIDENT DR. GRUBBS: Thank you.

25 Dr. Bishop, "License Applications"?

1 BOARD MEMBER DR. BISHOP: We have one
2 UROLA application for reciprocity for
3 Dr. Marcos Lenza.

4 Lou, if you would.

5 MS. SIMS: Okay. Dr. Lenza is applying
6 for a license by reciprocity UROLA. He has
7 been employed at UMC since 2023. He obtained
8 a provisional teaching license in '24. He
9 does qualify due to he's been licensed in the
10 state for over a year and he is a Mississippi
11 resident.

12 BOARD MEMBER DR. BISHOP: So I make a
13 motion we accept that?

14 BOARD PRESIDENT DR. GRUBBS: Second? Do
15 we have a second?

16 BOARD MEMBER DR. LAMPKIN: I'll second.

17 BOARD PRESIDENT DR. GRUBBS: Discussion?

18 (No response)

19 BOARD PRESIDENT DR. GRUBBS: All in
20 favor?

21 BOARD PANEL: Aye.

22 BOARD PRESIDENT DR. GRUBBS: Lou, you
23 still on?

24 MS. SIMS: So our next applicant for a
25 UROLA reciprocity is Correeda Johnson.

1 Correada is a resident of Mississippi, and
2 she's had a license in Tennessee for more
3 than eight years with no disciplinary
4 actions.

5 BOARD MEMBER MS. BIRMINGHAM: I'll make
6 a motion to approve Ms. Johnson for a dental
7 hygiene license.

8 BOARD PRESIDENT DR. GRUBBS: Second?

9 BOARD MEMBER DR. CARLTON: Second.

10 BOARD PRESIDENT DR. GRUBBS: Any
11 discussion?

12 (No response)

13 BOARD PRESIDENT DR. GRUBBS: All in
14 favor?

15 BOARD PANEL: Aye.

16 BOARD PRESIDENT DR. GRUBBS: Okay.
17 Dr. Carlton, "Specialty Applications." Do
18 you want her to do that one?

19 BOARD MEMBER DR. CARLTON: Absolutely.

20 MS. SIMS: So the first one is
21 Dr. Wennerholm. He was just recently issued
22 a license in October by examination. As you
23 see, he is applying for a specialty license
24 for dental anesthesiology. As you see, he
25 did complete his program in 2025; it is an

1 ADA-accredited program, and it was approved
2 by the AAP also.

3 BOARD MEMBER DR. CARLTON: I make a
4 motion we approve that.

5 BOARD MEMBER DR. LAMPKIN: Second.

6 BOARD PRESIDENT DR. GRUBBS: If you
7 would, Lou, just do all four of them.

8 EXECUTIVE DIRECTOR MR. HYDRICK: We have
9 one more specialty.

10 BOARD PRESIDENT DR. GRUBBS: Is that
11 okay with the Board if we do that? Y'all
12 okay with that?

13 EXECUTIVE DIRECTOR MR. HYDRICK: We have
14 one more specialty and then...

15 MS. SIMS: Okay. So the next specialty
16 application is for Dr. Lenza, which you all
17 just approved for a license by UROLA. He is
18 an orthodontist at UMMC.

19 BOARD PRESIDENT DR. GRUBBS: I got
20 ahead. John, do you want to set that up?

21 BOARD MEMBER DR. CARLTON: Yeah. I make
22 a motion to approve those two.

23 BOARD MEMBER DR. LAMPKIN: Second.

24 BOARD PRESIDENT DR. GRUBBS: Discussion?

25 (No response)

1 BOARD PRESIDENT DR. GRUBBS: Everybody
2 in favor?

3 BOARD PANEL: Aye.

4 BOARD PRESIDENT DR. GRUBBS: Thank you.
5 Now, Lou, you can go.

6 MS. SIMS: So next are Class I permits.
7 So we have Class I permits. And, as you see,
8 all did graduate their program, which was ADA
9 accredited. All were approved by the AAP.
10 As you see, I have a note on each explaining
11 each applicant's application.

12 So the first one is Jorge Romero. Jorge
13 was issued a license by reciprocity and a
14 specialty license in September of 2025. Now
15 he's applying for his Class I sedation permit.

16 The next one is Ross Stanley. Ross
17 Stanley was issued a license also by UROLA and
18 a specialty license in September of 2025.

19 Chad Wagner was issued a license by UROLA,
20 the Military Family Freedom Act. He was also
21 issued a specialty license on September 5th.

22 Chris Wennerholm, he was issued a license
23 recently. You all just approved his specialty
24 license. And, now, he's applying for his
25 sedation permit.

1 BOARD MEMBER DR. LAMPKIN: I make a
2 motion that we approve the Class I sedation
3 request.

4 BOARD PRESIDENT DR. GRUBBS: And we'll
5 note that we are doing these collectively.
6 Do I have a second?

7 BOARD MEMBER DR. JOE: Second.

8 BOARD MEMBER DR. CARLTON: All in favor?

9 BOARD PANEL: Aye.

10 BOARD PRESIDENT DR. GRUBBS: Or
11 discussion? I apologize. Does anybody want
12 to discuss this?

13 (No response)

14 BOARD PRESIDENT DR. GRUBBS: All in
15 favor?

16 BOARD PANEL: Aye.

17 BOARD PRESIDENT DR. GRUBBS: All right.
18 Thank you.

19 Class II?

20 MS. SIMS: For a Class II, both
21 applications were approved by the AAP. As
22 you see, they were also issued a dental
23 license, for Dr. Andrade, and a specialty
24 license. She is applying for Class II
25 sedation.

1 Also, Dr. Brahmbhatt, she is also applying
2 for a Class II permit.

3 BOARD MEMBER DR. LAMPKIN: I motion that
4 we accept the two Class II sedation requests
5 as follows.

6 BOARD PRESIDENT DR. GRUBBS: Do we have
7 a second?

8 BOARD MEMBER DR. CARLTON: Second.

9 BOARD PRESIDENT DR. GRUBBS: Discussion?

10 (No response)

11 BOARD PRESIDENT DR. GRUBBS: All those
12 in favor?

13 BOARD PANEL: Aye.

14 BOARD PRESIDENT DR. GRUBBS: Okay. We
15 have a request for reinstatement.

16 Dr. Joe and Ms. Sims?

17 MS. SIMS: A reinstatement for
18 Dr. Pettey. He was issued a license in 1997.
19 It voided, as you see all of the attachments.
20 He obtained a license in Tennessee in 2016.
21 He was teaching part time at UT, also still
22 working at his office in Meridian. In
23 August of 2019, he opened up a dental office
24 in Tennessee full time. Now, he's requesting
25 his Mississippi dental license to be

1 reinstated.

2 The next one is for dental hygiene, Hannah
3 Sumrall. She was issued a license in 2013;
4 voided 2019. She was issued a license in
5 Tennessee in 2016. She practiced in Tennessee
6 in 2016 to 2025. And, now, she has moved back
7 to Mississippi and wants to reinstate her
8 Mississippi dental hygiene license.

9 BOARD PRESIDENT DR. GRUBBS: Okay.
10 We're going to do these collectively, please.

11 Dr. Joe and Dr. Birmingham are going to
12 make a motion for us.

13 BOARD MEMBER DR. JOE: I make a motion
14 that we accept those requests for
15 reinstatement.

16 BOARD MEMBER DR. CARLTON: Second.

17 BOARD PRESIDENT DR. GRUBBS: Discussion?

18 BOARD ATTORNEY MR. MUTZIGER: Just to be
19 clear, Ms. Sims, the two applicants for
20 reinstatement here have met the appropriate
21 timing and educational requirements for
22 reinstatement?

23 MS. SIMS: Yes.

24 BOARD ATTORNEY MR. MUTZIGER: Okay.

25 BOARD PRESIDENT DR. GRUBBS: All in

1 favor?

2 BOARD PANEL: Aye.

3 BOARD PRESIDENT DR. GRUBBS: Thank you.

4 "Active Status," Ms. Birmingham?

5 BOARD MEMBER MS. BIRMINGHAM: Go ahead,
6 Lou.

7 MS. SIMS: All right. A request for
8 active status is for Lindsey McMinn. She's
9 been practicing in Tennessee, and she is
10 within her three years of practicing. She
11 has her ten-hour CE and CPR, completed the
12 Mississippi Jurisprudence Exam. As you see,
13 she has been practicing Tennessee all year
14 for Dr. Andrews. So she's within her three
15 years of requesting active status.

16 BOARD MEMBER MS. BIRMINGHAM: I just
17 want to make a motion to approve her license
18 for dental hygiene.

19 BOARD PRESIDENT DR. GRUBBS: Second?

20 BOARD MEMBER DR. LAMPKIN: Second.

21 BOARD PRESIDENT DR. GRUBBS: Discussion?

22 (No response)

23 BOARD PRESIDENT DR. GRUBBS: All in
24 favor?

25 BOARD PANEL: Aye.

1 BOARD PRESIDENT DR. GRUBBS: All right.

2 This brings us to our most fun section,

3 "Corporate Trade Names."

4 Tiffany?

5 DEPUTY DIRECTOR MS. VAUGHN: Yes, sir.

6 So the first one on the list is a request
7 for the name of Coastal Dental, PLLC. The
8 location is going to be 1033 Tommy Drive in
9 Biloxi, Mississippi. And this is being
10 requested by Dr. Eli Lowry, who was licensed in
11 2014. So, again, the name requested is Coastal
12 Dental, PLLC.

13 BOARD MEMBER DR. CARLTON: Is there any
14 hold-up with that name?

15 DEPUTY DIRECTOR MS. VAUGHN: No.

16 BOARD MEMBER DR. CARLTON: I make a
17 motion to approve that.

18 BOARD PRESIDENT DR. GRUBBS: Second?

19 BOARD MEMBER MS. BIRMINGHAM: Second.

20 BOARD PRESIDENT DR. GRUBBS: Discussion?

21 (No response)

22 BOARD PRESIDENT DR. GRUBBS: All in
23 favor?

24 BOARD PANEL: Aye.

25 DEPUTY DIRECTOR MS. VAUGHN: Okay. The

1 second one is going to be Dental
2 Professionals of Mississippi, PC, doing
3 business as Dental Care at East Sandidge
4 Center. This is being requested by Dr. James
5 Jackson, who was licensed in 2007. And an
6 additional dentist at the facility will be
7 Dr. Fortner. And this location for Dental
8 Professionals of Mississippi is in Olive
9 Branch. It's going to be in Olive Branch by
10 Dr. Jackson and Dr. Fortner.

11 BOARD MEMBER DR. CARLTON: I make a
12 motion to approve that.

13 BOARD PRESIDENT DR. GRUBBS: Do we have
14 a second?

15 BOARD MEMBER DR. JOE: Second.

16 BOARD PRESIDENT DR. GRUBBS: Discussion?

17 (No response)

18 BOARD PRESIDENT DR. GRUBBS: All in
19 favor?

20 BOARD PANEL: Aye.

21 DEPUTY DIRECTOR MS. VAUGHN: Okay.

22 Again, this is the same name, Dental
23 Professionals of Mississippi, PC, but they're
24 going to be doing business as Turtle Creek
25 Dental Care in Hattiesburg. The dentist

1 requesting this is a Dr. Duckworth, and
2 another dentist at the facility will be
3 Dr. Karen Luckett. So this is the same name,
4 Dental Professionals of Mississippi, but
5 they're doing business as Turtle Creek Dental
6 Care in Hattiesburg.

7 BOARD MEMBER DR. CARLTON: I make a
8 motion to approve that.

9 BOARD PRESIDENT DR. GRUBBS: Do we have
10 a second?

11 BOARD MEMBER DR. LAMPKIN: Second.

12 BOARD PRESIDENT DR. GRUBBS: Discussion?

13 (No response)

14 BOARD PRESIDENT DR. GRUBBS: Everybody
15 for?

16 BOARD PANEL: Aye.

17 BOARD PRESIDENT DR. GRUBBS: Denny, do
18 you want to address this next one or just --

19 EXECUTIVE DIRECTOR MR. HYDRICK: Sure.
20 We received a request from a dentist
21 regarding -- her questions were, you know,
22 can hygienists place silver diamine fluoride,
23 and I did find a Board determination that was
24 done in 2018, which determined that
25 hygienists could. So I let her know that.

1 That particular determination in 2018 said
2 that it had to be that they were under direct
3 supervision.

4 So the first question today is -- for the
5 Board to determine is, can SDF be placed under
6 general supervision?

7 And then the second question is -- from
8 the same dentist is, can dental hygienists
9 place Curodont? And so, I sent out some
10 information about Curodont in the packet.

11 So that's the two questions. And, if so,
12 is that under direct supervision only or both
13 direct and general if it's in the treatment?
14 So those are the questions.

15 BOARD VICE-PRESIDENT DR. CURTIS:

16 Mr. President, do I need to make a motion,
17 or can we just discuss it a little bit first?
18 What would be your pleasure?

19 BOARD PRESIDENT DR. GRUBBS: That would
20 be fine.

21 BOARD VICE-PRESIDENT DR. CURTIS: I have
22 thought about this, and, in my opinion, I
23 think the application for SDF or Curodont by
24 a dental hygienist under general supervision
25 would be acceptable as long as a diagnosis

1 has been made by the dentist ahead of time
2 and a prescription placed in the patient's
3 treatment plan prior to either one of those
4 procedures being done.

5 BOARD MEMBER MS. BIRMINGHAM: What --
6 but --

7 BOARD VICE-PRESIDENT DR. CURTIS: And
8 the diagnosis would be -- for Curodont would
9 be, let's say, demineralization --

10 BOARD MEMBER MS. BIRMINGHAM: Yeah.

11 BOARD VICE-PRESIDENT DR. CURTIS:
12 -- along the cervical margin of 7, 8, 9
13 and 10 secondary to orthodontic appliance or
14 something of that nature.

15 BOARD MEMBER MS. BIRMINGHAM: Yeah.

16 BOARD VICE-PRESIDENT DR. CURTIS: And
17 the same thing with SDF. The diagnostic code
18 would be incipient caries or high risk for
19 caries or something along those lines.

20 BOARD MEMBER MS. BIRMINGHAM: So like a
21 general diagnosis?

22 BOARD VICE-PRESIDENT DR. CURTIS: Yeah,
23 just a general diagnosis. If this needs to
24 be done, then put it in their treatment plan
25 and approve that the hygienists do it.

1 BOARD MEMBER MS. BIRMINGHAM: Okay.

2 Yeah.

3 BOARD VICE-PRESIDENT DR. CURTIS: I
4 would be in favor of that.

5 BOARD PRESIDENT DR. GRUBBS: So my
6 question to that would be -- and I'm not
7 opposed to what you're saying.

8 BOARD VICE-PRESIDENT DR. CURTIS: Yeah.

9 BOARD PRESIDENT DR. GRUBBS: So if a
10 hygienist operating under general supervision
11 sees that this needs to be done, they cannot
12 do it?

13 BOARD VICE-PRESIDENT DR. CURTIS: No, it
14 has to --

15 BOARD PRESIDENT DR. GRUBBS: I just want
16 to make sure that's --

17 BOARD VICE-PRESIDENT DR. CURTIS: The
18 dentist has to have diagnosed it and put it
19 in the treatment plan first.

20 BOARD MEMBER MS. BIRMINGHAM: And say a
21 return to clinic --

22 BOARD VICE-PRESIDENT DR. CURTIS: Yeah.

23 BOARD MEMBER MS. BIRMINGHAM: -- type
24 thing within the previous seven months.

25 BOARD VICE-PRESIDENT DR. CURTIS: Right.

1 BOARD MEMBER MS. BIRMINGHAM: But not on
2 the specific teeth?

3 BOARD VICE-PRESIDENT DR. CURTIS: No.

4 BOARD MEMBER MS. BIRMINGHAM: Just
5 general --

6 BOARD VICE-PRESIDENT DR. CURTIS: Right.

7 BOARD MEMBER MS. BIRMINGHAM: Okay. I
8 can live with that.

9 BOARD VICE-PRESIDENT DR. CURTIS: I just
10 think that takes the diagnosis part out of
11 the hands of the hygienists --

12 BOARD MEMBER MS. BIRMINGHAM: Yeah.
13 Sure.

14 BOARD VICE-PRESIDENT DR. CURTIS: -- and
15 places it squarely in the hands of the
16 dentist, "I'm making this diagnosis, and this
17 is my recommendation."

18 BOARD MEMBER MS. BIRMINGHAM: Because
19 sometimes it's used for sensitivity.

20 BOARD VICE-PRESIDENT DR. CURTIS: Yeah.
21 It could be for any number of things.

22 BOARD MEMBER MS. BIRMINGHAM: Right. As
23 long as it's in their treatment plan?

24 BOARD VICE-PRESIDENT DR. CURTIS: Right.

25 BOARD PRESIDENT DR. GRUBBS: Let's go

1 ahead and make a motion, and then we'll go
2 back to discuss it.

3 BOARD VICE-PRESIDENT DR. CURTIS: Okay.
4 So I move that we allow hygienists to place
5 SDF and/or Curodont to a patient as long as
6 the dentist has made a specific diagnosis and
7 placed into the patient's treatment plan
8 exactly what the intention is.

9 BOARD MEMBER MS. BIRMINGHAM: Within the
10 previous seven months.

11 BOARD VICE-PRESIDENT DR. CURTIS: Within
12 the previous seven months.

13 BOARD MEMBER DR. LAMPKIN: Second.

14 BOARD PRESIDENT DR. GRUBBS: Discussion?

15 BOARD MEMBER DR. DONALD: So by State
16 law, what is the definition between the
17 hygienist and the dentist doing treatment?
18 The dentist treats decay, right?

19 BOARD PRESIDENT DR. GRUBBS: Uh-huh
20 (affirmative response).

21 BOARD MEMBER DR. DONALD: Do hygienists
22 treat decay?

23 BOARD PRESIDENT DR. GRUBBS: No.

24 BOARD MEMBER DR. DONALD: According to
25 all of the documentations that I've received,

1 this is treatment of caries. So I think it
2 crosses the bridge, as it states in the State
3 law, that gives that authority to the
4 dentist. Whether it be diagnosis or not,
5 this is treatment; that this treatment should
6 be by the dentist under supervision, not
7 general supervision.

8 BOARD MEMBER MS. BIRMINGHAM: It's also
9 used for sensitivity, though. It's not just
10 used for --

11 BOARD MEMBER DR. DONALD: Let's let the
12 dentist decide that while you're in the room
13 with him, to pass that to you for treatment.
14 I'm not saying don't do it. I'm saying under
15 supervision, not general supervision.

16 BOARD ATTORNEY MR. MUTZIGER: One thing
17 we do have to acknowledge is with the change
18 of law last year regarding 73-9-5, it does
19 state that, "Under general supervision, a
20 dental hygienist may provide to patients of
21 record...all dental hygiene services (except
22 the administration of nitrous oxide...or
23 local anesthesia...) if all of the following
24 conditions are satisfied."

25 So the law would dictate that if the

1 service is, in fact, something a dental
2 hygienist can perform, if the other conditions
3 for general supervision are met, then it is --
4 the law would certainly be in favor of that
5 also being performed under general supervision.

6 We also have Regulation 13, which does
7 state that the dental -- bear with me, please.

8 Regulation 13, in its temporary form as
9 enacted, does state that "The supervising" -- I
10 apologize.

11 "The supervising dentist provide written
12 treatment protocols for patients seen under
13 general supervision, and the dental hygienist
14 shall adhere to such protocols."

15 Perhaps that would be the appropriate
16 section to also analyze this under.

17 BOARD MEMBER MS. BIRMINGHAM: I think
18 it's fine if the dentist is diagnosing.

19 BOARD MEMBER DR. CARLTON: I think it's
20 far different than taking a handpiece to a
21 tooth and restoring a tooth. I think it's
22 definitely not doing filling.

23 BOARD PRESIDENT DR. GRUBBS: Any other
24 discussion?

25 (No response)

1 BOARD PRESIDENT DR. GRUBBS: We had a
2 motion with a second, and we've discussed it.
3 All in favor?

4 BOARD PANEL: Aye.

5 BOARD PRESIDENT DR. GRUBBS: Opposed?

6 BOARD MEMBER DR. DONALD: Aye.

7 BOARD PRESIDENT DR. GRUBBS: Okay.

8 "Licenses and Permits Issued," Mr. Hydrick?

9 EXECUTIVE DIRECTOR MR. HYDRICK: That's
10 just a reference. It's in your packet of all
11 of the licenses and permits that the Board
12 has issued in the last quarter of -- excuse
13 me -- the first quarter of fiscal year '26.

14 BOARD PRESIDENT DR. GRUBBS: The
15 "Financial Report"?

16 EXECUTIVE DIRECTOR MR. HYDRICK: We
17 highlighted those, I think, during the
18 Committee report.

19 BOARD PRESIDENT DR. GRUBBS: Are you in
20 a hurry this morning?

21 EXECUTIVE DIRECTOR MR. HYDRICK: Sir?

22 BOARD PRESIDENT DR. GRUBBS: I'm sorry.

23 "End of the Year '25 Financial Report"?

24 EXECUTIVE DIRECTOR MR. HYDRICK: Again,
25 I think we hit the highlights of that, unless

1 someone has any questions about those
2 financials.

3 BOARD PRESIDENT DR. GRUBBS: All right.
4 "Executive Director's Report"?

5 EXECUTIVE DIRECTOR MR. HYDRICK: I
6 submitted a written report in your packet,
7 the "Executive Director's Report." And I
8 will certainly entertain any questions that
9 have come from that.

10 I will just give a quick update on license
11 renewals. You know, October 31st was the end
12 date for dentists to renew their licenses
13 without penalties. As of this morning, I
14 looked and we have 134 dentists who have not
15 renewed, which is, I think, pretty good for
16 this time where we are. Probably half of those
17 will not renew. They'll just let their license
18 void. So I still anticipate another 60 to 70
19 renewals coming in by the end of the year. So
20 they're allowed to renew up until December 31st
21 with penalties.

22 And other than some initial issues at the
23 beginning of the renewal cycle with our new
24 licensing system, once we've got those things
25 corrected, I think it's run pretty well.

1 Lou, Tiffany, would y'all agree of the
2 renewal process?

3 DEPUTY DIRECTOR MS. VAUGHN: (Nods head
4 affirmatively).

5 EXECUTIVE DIRECTOR MR. HYDRICK: So
6 we've processed, you know, almost 2,000
7 renewals, including specialties and sedation
8 permits, you know, in the last eight, nine
9 weeks, so...

10 BOARD PRESIDENT DR. GRUBBS: Denny, is
11 our software system -- are we up a hundred
12 percent now going?

13 EXECUTIVE DIRECTOR MR. HYDRICK: We're
14 at 90 percent, yes, sir. We've got, you
15 know, a few little things to work out mostly
16 on the enforcement side, not the licensing
17 side. But I think we're getting there.

18 BOARD PRESIDENT DR. GRUBBS: Okay.
19 "Committee Assignments," we've made those?

20 EXECUTIVE DIRECTOR MR. HYDRICK: They
21 need to be officially recorded.

22 BOARD PRESIDENT DR. GRUBBS: Yeah.

23 EXECUTIVE DIRECTOR MR. HYDRICK: Do you
24 want me to --

25 BOARD PRESIDENT DR. GRUBBS: If someone

1 doesn't like their assignment, please see me
2 after class; but, otherwise, we're going to
3 stay with what we've got.

4 EXECUTIVE DIRECTOR MR. HYDRICK: I will
5 just briefly remind the Board -- and we've
6 talked about this -- that one of our goals by
7 the end of the year is to develop some
8 bylaws.

9 And I know Dr. Donald has offered to help
10 with that; and so, now that he's official,
11 we're going to engage with him to do that. As
12 part of that process, though, I hope to be able
13 to redefine our committees. And, really, I
14 think the Board really needs two committees, an
15 Administrative Committee to handle budget,
16 finance, personnel, do reviews of the Executive
17 Director, those kinds of things; and an
18 Examination and Regulation Committee to, you
19 know, oversee the Board regulations, make
20 recommendations for changes to the Dental
21 Practice Act, and any examination questions
22 that come up.

23 So, hopefully, we will have those kind of
24 defined by the January Board meeting.

25 BOARD PRESIDENT DR. GRUBBS:

1 Dr. Williams, we're following your deal on
2 that as far as combining these committees. I
3 believe you mentioned something about that.

4 But, right now, they're the old way. So
5 y'all just give us a little bit of time to work
6 on that, and we'll squeeze that down to a
7 couple of them. And we'll work with Denny on
8 that.

9 Okay. We have had a request for an
10 appointment of a dentist and dental hygienist
11 to serve on the Council on Examination for the
12 American Board of Dental Examiners. Each must
13 currently be on the Board or have been on the
14 Board within the past five years.

15 Ms. Birmingham and Dr. Steve Porter have
16 said they would serve, unless someone else
17 wants to do that on this Board. If not, if
18 everybody is okay with that, I would like a
19 motion to approve these two.

20 BOARD MEMBER DR. BISHOP: So moved.

21 BOARD MEMBER DR. LAMPKIN: Second.

22 BOARD PRESIDENT DR. GRUBBS: Discussion?

23 (No response)

24 BOARD PRESIDENT DR. GRUBBS: All in
25 favor?

1 BOARD PANEL: Aye.

2 BOARD PRESIDENT DR. GRUBBS: All right.

3 I guess we'll go into the public hearing
4 time.

5 EXECUTIVE DIRECTOR MR. HYDRICK:

6 Dr. Grubbs, I will make one note of a
7 change in this section. Dr. Leach contacted me
8 this morning and asked to be removed from the
9 speakers list, so he will not be on -- he will
10 not be speaking this morning.

11 BOARD PRESIDENT DR. GRUBBS: Okay.

12 EXECUTIVE DIRECTOR MR. HYDRICK: And for
13 our speakers, just before we get started,
14 when it's your time, if you'll sit here in
15 the middle. I know that some of you have
16 exhibits. If you'll reference that, you
17 know, out loud, I can pull it up and it be
18 displayed on the screen.

19 There will be 15 minutes allotted for each
20 speaker. And so, there will be a timer on the
21 screen so that you'll know how to budget your
22 time, so to speak.

23 If we could maybe take like a two-minute
24 break for me to do some transition into that?

25 BOARD PRESIDENT DR. GRUBBS: Let's just

1 go ahead and take a break for ten minutes.

2 It's 9:08, so 9:18. Is that all right?

3 Dr. Bishop, are you okay with that?

4 BOARD MEMBER DR. BISHOP: Uh-huh
5 (affirmative response).

6 (OFF THE RECORD)

7 BOARD ATTORNEY MR. MUTZIGER: Are we
8 ready to begin oral proceeding?

9 BOARD PRESIDENT DR. GRUBBS: Yes.

10 PUBLIC HEARING/ORAL PROCEEDING

11 BOARD ATTORNEY MR. MUTZIGER: So the
12 Board has filed proposed changes for
13 Regulations 37, 53, 61, and 62 back in July.
14 According to the Administrative Procedures
15 Act, once proposed changes are filed to
16 regulations, if a sufficient number of
17 parties request for an oral proceeding, the
18 Board is mandated to hold an oral proceeding.

19 The Board received more than the required
20 number of requests; and, thus, we are here
21 today.

22 Regulation 37 is regarding fees. The
23 changes into 37 are related to Regulation 61
24 and 62, Mobile and Portable Dental Facilities.

25 Regulation 53 is related to the

1 documentation requirements in the patient
2 record, as well as the storage of patient
3 records by practitioners. It was also
4 previously including informed consent.

5 I will now note that the Board has voted
6 to strike that. As such, we would ask that the
7 presentation be limited to only those items
8 that will be moving forward regarding this
9 filing; that is, informed consent has been
10 taken off the table. Of course, the Board may
11 revisit that at a future date, but informed
12 consent is no longer a part of this regulatory
13 filing.

14 MS. ASHLEY CASEY: May I add something?
15 Since it was mentioned that it would be
16 coming back at a later date, I do have a few
17 points that I would like to just briefly
18 touch on.

19 BOARD PRESIDENT DR. GRUBBS: I don't
20 know that he said it would be. He said it's
21 a possibility. Does that make a difference?

22 MS. ASHLEY CASEY: Well, I just wanted
23 it on the record since originally it was in
24 there for today's hearing.

25 BOARD ATTORNEY MR. MUTZIGER: And I

1 would note that should it come up again, that
2 will require an additional filing by this
3 Board. And, at that time, you would, once
4 again, be able to request an oral proceeding.
5 So this process could, in fact, be duplicated
6 if that were to occur down the road.

7 I would leave it up to the Chair's
8 discretion as to whether or not that will be
9 allowed on the record, perhaps briefly.

10 MS. ASHLEY CASEY: Yeah, it's two
11 sentences.

12 BOARD ATTORNEY MR. MUTZIGER: Okay. I
13 don't necessarily see that as an issue.

14 So I will say that 61 and 62, the changes
15 in those regulations are regarding mobile and
16 portable dental facilities. While there have
17 been changes, it is largely changes in form and
18 structure, organization. It is an attempt by
19 this Board to make those regulations more
20 user-friendly, easier to understand. The
21 changes in the regulations are not substantial
22 deviations from those which are already in
23 place in Regulations 61 and 62.

24 The primary change that is sought to be
25 effectuated in Regulations 61 and 62 is the

1 renewal of portable and mobile dental facility
2 permits. That is so that the Board may
3 continue to collect up-to-date, relevant
4 information on these permitted providers for
5 effective regulation of those providers.

6 The process today will be that each
7 presenter will be given 15 minutes to address
8 the proposed regulations. There have been
9 materials submitted by the presenters. Those
10 are available today on your computers.

11 Following completion of the presentation
12 by the presenter, the Board is allowed to ask
13 questions of the presenter; and it is at the
14 Board Chair's discretion of how long that will
15 continue.

16 With that being said, I don't believe I
17 have anything further. I would, then, turn it
18 over to Ms. Casey, for your presentation, if
19 you are ready.

20 MS. ASHLEY CASEY: Denny, you had asked
21 me to pull up an exhibit, and I do just have
22 one.

23 EXECUTIVE DIRECTOR MR. HYDRICK: What
24 number? It's not going to come on the
25 screen. I'll have to do it.

1 MS. ASHLEY CASEY: Oh, I'm sorry. Okay.
2 It's 42. So if we could pull that one up,
3 then I'll reference them other ways. But, I
4 mean, we don't have to spend the time...

5 EXECUTIVE DIRECTOR MR. HYDRICK: Let me
6 find it for you. You said 42?

7 MS. ASHLEY CASEY: 42, yes, sir, and
8 it's several pages down.

9 EXECUTIVE DIRECTOR MR. HYDRICK: Is that
10 it?

11 MS. ASHLEY CASEY: Yes, sir. If you'll
12 just scroll down, I'll tell you the page.

13 EXECUTIVE DIRECTOR MR. HYDRICK: Did I
14 miss it?

15 MS. ASHLEY CASEY: No, it's that one
16 coming up.

17 EXECUTIVE DIRECTOR MR. HYDRICK: This
18 one?

19 MS. ASHLEY CASEY: Yes, sir.

20 EXECUTIVE DIRECTOR MR. HYDRICK: Okay.
21 I'll make it bigger once we start the time so
22 that everybody can see it.

23 You just let me know when you're ready,
24 and we'll --

25 MS. ASHLEY CASEY: I'm ready.

1 EXECUTIVE DIRECTOR MR. HYDRICK: Okay.

2 PRESENTATION BY ASHLEY CASEY, RN

3 MS. ASHLEY CASEY: Good morning. Thank
4 you for this opportunity to speak before you
5 today, as I have waited a long time for it.

6 I submitted a 71-page outline of my
7 position points in regards to the proposed
8 amendments to Regulations 37, 53, 61, and 62.
9 In preparation for this oral hearing, I found
10 myself trying to justify and explain the need
11 for mobile/portable dentistry; and then I
12 realized I do not have to justify it.

13 If you are a resident living in one of the
14 poorest states in the nation that also ranks
15 lowest in oral health care, with almost every
16 county in this state having 100 percent free
17 and reduced lunches within schools, then you
18 already see a need and understand it.

19 While the proposed amendments to
20 Regulation 53 were striked concerning informed
21 consent, it is important to note that these
22 same proposals were originally introduced under
23 the Regulations 61 and 62 back in October of
24 2024, Exhibit 42. The intent was never to make
25 this consent rule applicable to all licensed

1 dentists, but rather only for mobile and
2 portable dentists; the Statute 73-49-1,
3 discrimination amongst dental licensees.

4 In several different Board meetings,
5 Dr. Curtis has stated that he did not want
6 mobile and portable dental consent forms
7 included in the school registration packets.
8 He knows that we are unable to schedule
9 150-plus schools to be seen within 14 days of a
10 parent signing up their child to be seen in our
11 dental outreach program. It doesn't get more
12 obvious than that.

13 In addition, Dr. Curtis, at the
14 October 2024 meeting, made the recommendations
15 of conducting random audits to ensure
16 compliance with the Board's regulation.
17 Dr. Grubbs asked Mr. Hydrick about the
18 performance of random audits currently.
19 Mr. Hydrick stated that the Board would have to
20 know in real time the schedules and locations
21 of these units to perform random audits.
22 Dr. Curtis suggested that an audit of the
23 patient records at a central office location
24 would suffice.

25 So there is no complaint of the quality of

1 care that we are providing and delivering to
2 these students. You all are more concerned
3 that we have every form in place.

4 Question: How many random chart audits
5 does the Board conduct in private practice
6 dental offices?

7 In that same meeting, Mr. Mutziger
8 reminded the Committee of the State's policy to
9 utilize the least restrictive regulations
10 necessary to protect the public.

11 Moving on. A lot of the proposed changes
12 around fees and inspections for 61 and 62,
13 pages 41 through 71, is a straight
14 misinterpretation of the current regulation,
15 which I go into great detail explaining.

16 Removal of mobile and portable dentistry
17 definitions is ludicrous. The one sentence
18 that states mobile and portable dentistry is
19 held to the exact same standard as land-based
20 dental facilities, and the Board wants that
21 removed? It's almost like you want us to be
22 held to different standards.

23 The only difference between land-based
24 dental facilities and mobile/portable dental
25 facilities is that we can move locations. We

1 utilize the exact same equipment, perform the
2 same preventive dental services with the same
3 equally licensed personnel. We are not
4 inferior to land-based facilities, nor do we
5 provide inferior care.

6 If this consent rule would have been
7 passed or is up for consideration again, it
8 would violate equal protection and substantive
9 due process under both the U.S. and Mississippi
10 Constitutions. In terms of equal probation,
11 the rule treats mobile/portable dentists
12 different than dentists who operate out of
13 brick and mortar for no rational reason. For
14 substantive due process, the rule would
15 essentially bar professionals from practicing
16 their chosen and lawful profession.

17 Laws that are currently being violated,
18 Statute 73-9-19, registration of dentists;
19 Statute 73-9-13, pages 13 through 15,
20 Exhibit 7, officers of Board duties and powers.

21 When asked to produce a list of all
22 licensed dentists holding a mobile or portable
23 dental permit, the Board could not produce it.
24 An excuse was given that the Board is still in
25 the process of integrating data into its new

1 licensure database. However, I would like to
2 be clear, a regulation for mobile dentistry has
3 been in place since 2005, 20 years, and no one
4 can give me a list of permitted dentists. No
5 excuses are acceptable for this lack of
6 record-keeping.

7 Question: If the Board had requested from
8 me a list of all schools we serve along with
9 their addresses and I told them that I could
10 not produce it or I don't have it, what would
11 have happened to us?

12 The current regulation, 53, states, quote,
13 "The inability and/or failure to produce such
14 records when so requested by the Mississippi
15 State Board of Dental Examiners shall be
16 considered a violation of this regulation, and
17 the licensee may be subject to formal
18 disciplinary action by the Board."

19 Note the word "shall." And as the Board
20 has defined it in Regulation 30, "shall" or
21 "must" indicates an imperative need or duty or
22 both, mandatory.

23 The Board's mission statement, "The
24 Mississippi State Board of Dental Examiners,
25 the Board, is a legislatively mandated State

1 regulatory agency charged with the
2 responsibilities of examining, licensing,
3 registering, and regulating the practices of
4 dentistry and dental hygiene to ensure
5 competency through examination and licensure
6 and ethics through registration and regulation
7 among all dental professionals in the State of
8 Mississippi for the ultimate goal of
9 safeguarding and enhancing the health and
10 welfare of the citizens of this State."

11 The responsibility of this charge lies on
12 the Board members. The buck stops at your
13 desk. My recommendation is to get this house
14 in order so that you can properly and
15 competently regulate and enforce equal
16 regulations of all licensed dental
17 professionals.

18 These proposed amendments are not equal,
19 and the real intent of trying to discriminate
20 against mobile and portable dentists has been
21 brought to light. I have included in my
22 submission Exhibits 56 through 58, two prior
23 complaints against two sitting Board members,
24 who have aggressively and unethically harassed
25 and attacked my mobile/portable company.

1 However, I have also attached -- and I
2 have these two articles published proclaiming
3 their support of the work that mobile and
4 portable dentistry provides to underserved.

5 I will leave you with a few words from a
6 support letter from the largest school district
7 in the State, DeSoto County's Director of
8 Health Services.

9 "We are fortunate to have such a dedicated
10 group of professionals serving our schools. I
11 strongly commend their work and encourage
12 continued support for mobile dental programs
13 that make preventive care more accessible for
14 children across our state. Please do not
15 approve of putting barriers in place that will
16 make it impossible for this service to be
17 offered at the school level, such as placing a
18 short timeline after parental consent for
19 services to be rendered. We have not had a
20 single complaint from a parent about any
21 services their child received or when they
22 received it since we have been partnering with
23 Smiles To Go. Obstacles such as that will only
24 hurt the very children we are trying to help.
25 Please consider the children's oral health

1 first and the barriers they must overcome to
2 receive the dental services they so desperately
3 need. Thank you for your time and supporting
4 initiatives that promote the dental health of
5 school-age children."

6 I had to readjust from yesterday's
7 meeting. But in the same October 2024 meeting,
8 it was voiced -- and I think, Dr. Joe, you were
9 the one that stated, "I would like to hear from
10 some mobile providers." Dr. Williams asked for
11 a questionnaire to be sent out to the providers
12 asking questions.

13 I have sat for over a year and a half
14 right there at every meeting. So when you ask
15 to hear, I've been here. You, for other
16 regulations, have formed expert panels. You've
17 included -- you get input from the gallery on
18 so many different -- anytime I've ever tried to
19 make a comment, I'm shut down immediately.
20 It's totally inappropriate for her to say
21 anything.

22 If the true intent is to work and get this
23 regulation that is enforceable, then we're
24 here; we are here. You have no mobile
25 dentists, mobile companies that want to sit at

1 the table.

2 Okay. Now, what I will say is if you're
3 in this room, you're intelligent. Okay.
4 You're a doctor. Okay. You deserve a seat at
5 the table. But what I'm not going to do is
6 insult anybody's intelligence in this room by
7 sitting up here and acting like we don't know.

8 Okay. So a lot of this stuff that was
9 proposed, no lie, was a waste of time. If we
10 would have had discussion going back and forth
11 for the past year and a half -- even yesterday
12 we didn't have discussion, okay, totally
13 striked, removed.

14 Once again, if the Board's intent is to
15 get to where we can all have a great
16 regulation, we're here. You know where to find
17 us. I'm always right there.

18 If the intent is not that and it's just to
19 stop our program, as actions have been taken,
20 then we'll let that play out as it will.

21 I want y'all to know this, that we are not
22 here fighting the Board; I'm not. Okay. I'm
23 fighting for the children. That's who I'm
24 fighting for. That is a much greater cause.
25 It's the one that makes me get up in the

1 morning. Because I'm going to tell you, on
2 some of these mornings, there's not enough
3 money in the world that could make some of this
4 acceptable; there's not.

5 So on the days that I want to quit and I
6 want to say, "Hey, quit," I remind myself, "Why
7 did I start it?" I didn't start it for money.
8 I started it to genuinely help. I'm a public
9 health advocate. I love what I do, and I truly
10 feel that this is my mission and my calling.

11 So if there is an issue or if I've done
12 something, by all means, I can assure you it's
13 not intentional and I will correct it. Tell
14 me. Okay. But let's have discussion with
15 that.

16 I think that's pretty much all that I have
17 to say on this. So if we want to start
18 questions.

19 BOARD ATTORNEY MR. MUTZIGER: Thank you,
20 Ms. Casey.

21 Does any of the Board have any questions
22 for Ms. Casey at this time regarding her
23 presentation?

24 BOARD MEMBER DR. JOE: I'm curious as to
25 how many of the urgent needs of these kids

1 are taken care of, as far as extractions,
2 pulpotomies?

3 MS. ASHLEY CASEY: So we have people
4 that follow up and make phone calls. We'll
5 send texts. We are always there offering if
6 they don't understand.

7 For example, one of the ones required so
8 much extensive work to be treated that a -- you
9 can't just send them to a general dentist.
10 Okay. So it was going to require
11 hospitalization. So, therefore, we had to
12 directly intervene and partner with the dentist
13 that was going to be doing the hospital
14 surgeries. So we would call afterwards. If we
15 have it down that their appointment is on this
16 date, I would call and I would, probably a week
17 after, check with the school nurse. And I'd
18 say, "Hey, look. I can't get ahold of momma.
19 Could you go down there and just check on
20 Little Jimmy and let me know how he's doing?
21 How it went?"

22 Some cases, it's beautiful. Everything
23 went great. In fact, they had to schedule
24 multiple appointments. They couldn't do it all
25 in one; it was too traumatic. Other times you

1 do have cases where the school nurse will come
2 back and say, "Ash, they didn't get it done."
3 And, then, so that phone call to the parent is
4 very different than the first phone call I had.

5 So when I call them that time, it's a --
6 because I'm a nurse by trade, so it's more --
7 in fact, I had an example, and it was a special
8 needs kid. And I called back and I was
9 prepared to go to war with her. And she
10 answered, and she said, "I'm so happy you
11 called because we're in a custody battle now."
12 It was the aunt. So the aunt was removing the
13 kid from the mother.

14 So there's so many different cases that we
15 have. Sometime it's fantastic outcomes. I'm
16 sure a lot of y'all's is the same way; that
17 even though you propose a treatment plan, you
18 can't force them to get it done. Sometimes
19 they'll say, "Well, let me save up. Let me do
20 some of this and I'll come back."

21 So, you know, we try our best.

22 BOARD ATTORNEY MR. MUTZIGER: No other
23 questions from Board members?

24 (No response)

25 BOARD ATTORNEY MR. MUTZIGER: Okay. So

1 if there are no other questions from Board
2 members, then that will conclude your
3 presentation, Ms. Casey. We thank you.

4 MS. ASHLEY CASEY: And this was the two
5 articles and the support letter.

6 BOARD ATTORNEY MR. MUTZIGER: We will
7 include those with the materials that you
8 previously submitted. Thank you.

9 EXECUTIVE DIRECTOR MR. HYDRICK: All
10 right. I believe everyone else has asked to
11 be removed off the speakers list for this
12 morning.

13 BOARD ATTORNEY MR. MUTZIGER: Are there
14 any other speakers present that previously
15 submitted a speaker request form that wishes
16 to proceed with their presentation to the
17 Board today?

18 (No response)

19 BOARD ATTORNEY MR. MUTZIGER: Okay.
20 Well, it looks like that will conclude the
21 oral proceeding, then.

22 What do we have next on our agenda for the
23 Board?

24 EXECUTIVE DIRECTOR MR. HYDRICK:
25 Consideration to enter executive session.

1 BOARD ATTORNEY MR. MUTZIGER: So at this
2 time, if the Board believes that there may be
3 cause to go into executive session, there
4 would need to be a motion to enter closed
5 session to determine if executive session is
6 appropriate.

7 BOARD MEMBER DR. LAMPKIN: So moved.

8 BOARD ATTORNEY MR. MUTZIGER: So you
9 have a motion. You need to ask for a second.

10 BOARD PRESIDENT DR. GRUBBS: Go ahead.

11 BOARD ATTORNEY MR. MUTZIGER: Is there a
12 second to the motion?

13 BOARD MEMBER DR. DONALD: Second.

14 BOARD PRESIDENT DR. GRUBBS: All in
15 favor?

16 BOARD PANEL: Aye.

17 BOARD ATTORNEY MR. MUTZIGER: So at this
18 time, the Board will enter closed
19 determination to see if executive session is
20 appropriate. At this time, we would ask that
21 our guests kindly go across the hall into our
22 conference room while the Board is in closed
23 session. Thank you.

24 I will announce to the public attendees
25 the results of the determination once it has

1 been made.

2 (PUBLIC ATTENDEES EXIT HEARING ROOM)

3 BOARD ATTORNEY MR. MUTZIGER: Let me
4 grab a copy of my agenda, please.

5 I would advise to the Board that there is
6 cause for executive session for consideration
7 of investigatory matters pending before the
8 Board, as well as consideration of a proposed
9 consent order, as well as the Board's
10 consideration of a document exempt from the
11 Public Records Act.

12 BOARD MEMBER DR. DONALD: So moved to go
13 into executive session.

14 BOARD MEMBER DR. LAMPKIN: Second.

15 BOARD PRESIDENT DR. GRUBBS: All in
16 favor?

17 BOARD PANEL: Aye.

18 BOARD ATTORNEY MR. MUTZIGER: So at this
19 time, the Board has voted to go into
20 executive session.

21 *****

23 *****

24 (EXIT EXECUTIVE SESSION)

1 BOARD PRESIDENT DR. GRUBBS: We're
2 returning to open session.

3 REPORT OF BOARD ACTIONS

4 BOARD ATTORNEY MR. MUTZIGER: Yes, sir.
5 So I do have a report of the actions taken by
6 the Board in executive session.

7 The Board voted to approve the proposed
8 remands, letters of concern; and as identified
9 in Exhibit D, the Board voted to approve the
10 consent order regarding Docket Numbers
11 2024-046, 2024-116, and 2025-083.

12 (EXHIBIT NUMBER 2 MARKED)

13 BOARD ATTORNEY MR. MUTZIGER: The Board
14 voted to set for hearing the noncompliance
15 related to Case Numbers 2020-070, 2025-072,
16 and 2025-073.

17 And the Board voted to approve the formal
18 response to the draft Peer Committee Report,
19 which will be issued to the Peer Committee.

20 And that concludes the report of actions
21 taken in executive session.

22 Now that we have returned to open session,
23 I will bring it back to the Board that as we
24 have concluded the oral proceeding today, it is
25 within the Board's purview to move to vote to

1 go forward with the process, which the next
2 step is submitting to the OLRC those proposed
3 regulations. You may vote today to refer it
4 back to the Rules and Regulations Committee, if
5 you so choose, for further consideration given
6 the public remarks today; or you may also vote
7 to proceed with the process of following with
8 the OLRC proposed Regulations 37, 53, 61, and
9 62.

10 So I would ask that the Board give -- or
11 entertain that question and provide direction
12 so that the staff may effectuate its will.

13 BOARD PRESIDENT DR. GRUBBS: Do we have
14 any motions?

15 BOARD VICE-PRESIDENT DR. CURTIS: Yes.
16 I move that the staff proceed in moving those
17 four items forward.

18 BOARD ATTORNEY MR. MUTZIGER: And that
19 would be to file with the OLRC Regulations
20 37, 53, -- and, of course, that's 53 with
21 Item No. 3 stricken -- 61, and 62?

22 BOARD VICE-PRESIDENT DR. CURTIS:
23 Correct.

24 BOARD MEMBER DR. DONALD: Second.

25 BOARD ATTORNEY MR. MUTZIGER: Any

1 discussion?

2 (No response)

3 BOARD PRESIDENT DR. GRUBBS: Anybody?

4 (No response)

5 BOARD PRESIDENT DR. GRUBBS: All in
6 favor?

7 BOARD PANEL: Aye.

8 BOARD ATTORNEY MR. MUTZIGER: Okay.
9 That's what I needed. I don't believe I have
10 anything further.

11 Denny, do you have anything further?

12 EXECUTIVE DIRECTOR MR. HYDRICK: Just be
13 sure to sign your travel form if you have one
14 in your folder and give that to me. They
15 only go through October 31st. So for this
16 meeting, your travel will be on the next
17 expense report for today. We do have lunch.
18 I know we're getting through really early,
19 thankfully; but, if you would, please eat
20 some lunch before you leave.

21 And I think that's all that I have.

22 BOARD PRESIDENT DR. GRUBBS: All right.
23 We need a motion to adjourn.

24 BOARD MEMBER DR. DONALD: So moved.

25 BOARD MEMBER MS. BIRMINGHAM: Second.

1 BOARD PRESIDENT DR. GRUBBS: All in
2 favor?

3 BOARD PANEL: Aye.
